



Directions to the AFPMB

Recommended Route:

- From the northside "Capital Beltway" (I -495), take Exit 31B (approaching from the west/inner loop) or 31A (approaching from the east/outer loop) onto Georgia Avenue South.
- At the 2nd traffic light on Georgia Ave. S., turn right on Seminary Road (not Seminary Place).
- Follow Seminary Road through a traffic light and stay in the right lane after the traffic light. The main road will bear left, but you should continue straight onto Linden Lane; stay on Linden Lane, through a stop sign, over a railroad bridge, and take the first left into the base.
- Proceed through the Security Checkpoint on Stephen Sitter Ave.
- Sitter Ave. will bear left and go downhill. At bottom of hill, turn left and proceed up past gas station and just past the sharp curve the AFPMB building is on your right.
- Park beside Bldg 172 or in the Commissary parking lot.
- Enter Bldg. 172 through center double doors under porch.

ALLOWED PARKING ON U.S.ARMY GARRISON FOREST GLEN

For all visitors to the Armed Forces Pest Management Board office, please be aware of the parking restrictions on this post. You will have only FOUR areas on post where you can park. In two of those areas, you will be walking a ways to get to Bldg 172.

The areas where you can park are in GREEN with the words, "PARK HERE." These areas are:

1. The 12 parallel parking slots along the curb that runs north of the entrance for Bldg 172's parking lot.
2. The first five parking rows in the corner of the Commissary parking lot closest to Bldg 172.
3. The parking area behind the U.S. Army Garrison Forest Glen Gym, Bldg 154. If you enter the U.S. Army Garrison Forest Glen through the Linden Lane Entrance, the post gym is the small building on the right once you've gone past the Child Development Center (which is on your left). Drive down the hill past Bldg 154 to the parking area. You will then need to walk to Bldg 172.
4. The large parking area immediately west of the Walter Reed Army Institute of Research. Parking could be limited there. Do not park in reserved or designated parking slots. You will then need to walk to Bldg 172.

DO NOT park in any area indicated in RED on the map and labeled with the words, "NO PARKING."

DO NOT park in the Child Development Center's parking lot. It is designated for the Center.

DO NOT park in Bldg 172's parking lot. It is designated for the permanent staff members of Bldgs 172 and 172A.

DO try to arrive early to increase your chances of getting a parking space close to Bldg 172.

DO consider carpooling with fellow attendees to the Board meetings during the week.
